This Copyright Transfer Agreement for Creative Works in Accordance with University Curriculum is entered into by and between:

Hereinafter referred to as the “Transferor,” of the one part, and

Bangkok University, located at No. 9/1, Moo 5, Phaholyothin Road, Khlong Nueng Sub-district, Khlong Luang District, Pathum Thani 12120, represented by ..... (position: .....), acting as an attorney in fact of the President of Bangkok University, hereinafter referred to as the “Transferee,” of the other part.

The Transferor and the Transferee agree as follows:

Clause 1: Under this Agreement, the Transferor certifies that they are the creator and owner of the copyrighted work entitled: ....., hereinafter referred to as the “Copyrighted Work.” Details of the Copyrighted Work are provided in Appendix No. ...

Clause 2: The Transferor agrees to transfer the copyright of the Copyrighted Work, including all owner’s rights under copyright law, to the Transferee effective from the date of this Agreement. The transfer of copyright shall remain effective for the duration of the copyright protection under the law, unless otherwise agreed.

The transfer is made with compensation, and as of the date of this Agreement, the Transferor has received full compensation from the Transferee.

The transfer is made without compensation.

Clause 3: The Transferor certifies that, as of the date of this Agreement, the Copyrighted Work, in whole or in part, is not subject to any license agreements with third parties. The Transferor agrees not to use, reproduce, modify, distribute, or perform any other acts that would infringe on the Transferee’s copyright in the Copyrighted Work without prior written consent from the Transferee.

Clause 4: Should it later emerge that the Copyrighted Work infringes on the intellectual property rights of others and/or the Transferee's rights are disturbed and/or the Transferee is accused or sued for intellectual property infringement due to the Transferor's Copyrighted Work, and/or the Transferor violates the warranties provided under this Agreement, causing harm to the Transferee, the Transferor shall be responsible for compensating the Transferee for all damages incurred.

Clause 5: If the Copyrighted Work generates revenue and/or commercial benefits for the Transferee, the Transferee may consider allocating a portion or all of the benefits derived from the Copyrighted Work to the Transferor in the future, subject to Bangkok University's regulations on intellectual property management and benefit allocation from intellectual property.

This Agreement is made in duplicate with identical content. Both the Transferor and the Transferee have read and fully understood the terms of this Agreement and hereby affix their signatures in the presence of witnesses. Each party retains one copy.
