Clause 3: The Licensor affirms that the Thesis/Independent Study/Dissertation does not infringe on the copyright of others. In the event of any lawsuits or complaints regarding copyright infringement involving the Thesis/Independent Study/Dissertation and/or if the Licensor violates any terms of this Agreement, causing damage to the Licensee, the Licensor shall be solely responsible for all damages incurred.

This Agreement is made in duplicate, with both copies having the same content. Both the Licensor and the Licensee have read and fully understood the terms of this Agreement and have signed it in the presence of witnesses, with each party retaining one copy.
